PRIVACY POLICY

Tooliers Inc. is serious about protecting your online privacy. Therefore, we take outmost care to process your personal data in accordance with the principles set forth in the data protection legislation applicable in the European Union, including Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC ("GDPR"). Personal data represents any information relating to an identified or identifiable natural person, and an identifiable person is that person that may be identified directly or indirectly, particularly by reference to an identification number or to one or more factors specific to its physical, psychological, mental, economic, cultural or social identity.

1.6. If you are a visitor of our premises

We use your personal data in order to ensure the security of our premises, assets and personnel. In this case, we base our data processing on the legitimate interest of our company, namely the protection of such premises, assets and personnel.

The categories of data processed in this context are your name as well as other personal data you may provide directly to us.

1.7. If you are a user of our website

We use the personal data we collect from you when you visit our Internet site, in order to monitor the traffic and improve the content of the website. We base this data processing activity on our legitimate interest in ensuring the proper functioning of our website, as well as its improvement.

The categories of data processed in this context are the hour and date of accessing the website and the IP address from which our website was accessed.

For all above categories of data subjects, we may also process your data in the context of changes in structure or similar transactions involving any of our entities. In this case, the grounds for processing may be represented by the legal obligation (in case we are legally obliged to disclose certain personal data to public authorities), the performance of the agreement concluded by us in the context delivering our products and services (if you are a party to such agreement) or our legitimate interest to carry out the work we do in the most effective manner (in the rest of the cases).

In summary, when you purchase something from our site, as part of the buying and selling process, we collect the personal information you give us such as your name, address and email address. In certain cases your phone number. This enables us to both fulfill and support the products you purchase.

When you browse our site, we also automatically receive your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system so we can better improve the experience for all our users.

2. CONSENT

When you provide us with personal information to download a document, access content, complete a transaction, verify your credit card, place an order, arrange for a delivery or return a purchase, we understand that you consent to our collecting it and using it for that specific reason and for receiving relevant information from us.

3. DISCLOSURE

We may disclose your personal information if we are required by law to do so or if you violate our Terms of Service. Also, if our site is acquired or merged with another company, your information may be transferred to the new owners so that they may continue to sell and support our products and services.

We do not sell, rent or otherwise disclose your personal information to any third parties, including but not limited to advertisers, strategic partners or vendors, unless you specifically ask us to.

We take your privacy very seriously.

4. DATA STORAGE

Our CRM and e-commerce software is hosted and managed by Infusionsoft. They provide us with the online e-commerce platform that allows us to sell our products and services to you. Your data is stored through Infusionsoft's data storage, databases and the general Infusionsoft application. They store your data on a secure server behind a firewall. We process our payments using the online shopping card solution SamCart Inc. https://samcart.com and Stripe as merchant account and payment gateway https://stripe.com. If you choose a direct payment gateway to complete your purchase, then SamCart Inc stores your credit card data. It is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS). Your purchase transaction data is stored only as long as is necessary to complete your purchase transaction. After that is complete, your purchase transaction information is deleted.

All direct payment gateways adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover.

PCI-DSS requirements help ensure the secure handling of credit card information by our platform and its service providers.

Tooliers Inc. does not take custody or store your credit card information. This process is monitored and managed by SamCart Inc, and you can read their terms of service, privacy policy and PCI Compliance information by visiting their site.

5. THIRD-PARTY SERVICES

In general, the third-party providers used by us will only collect, use and disclose your information to the extent necessary to allow them to perform the services they provide to us. However, certain third-party service providers, such as payment gateways and other payment transaction processors, have their own privacy policies in respect to the information we are required to provide to them for your purchase-related transactions.

We use remarking pixels from Facebook and Google to aid in customized, targeted follow-up advertising.

From time to time we use other tools to track our traffic and to understand our users' behavior so we improve our users' experience.
