

TERMS AND CONDITIONS

Please read these terms of use carefully before you start to use the site. By using tooliers.com, you agree to comply with these terms and conditions.

1 TERMS EXPLAINED

The terms below are explained:

- "the platform" or "the site" is interchangeably used for tooliers.com and ozanagiusca.com
- "we" or "us" or "our(s)" refers to the company that provides and operates the platform. This also includes our related companies in the countries where we have a physical presence.
- "visitor" refers to a person who visits the site, without registering, and simply accesses the information contained on the site.
- "user" refers to a person who registers with the site and uses free products, but does not make any purchase.
- "client" refers to a person who uses the products displayed on this website, and (s)he has paid for them.
- "you" refers to any one of the following: visitor, user, client.
- "products" represent all the tools, programs and services displayed on the website, regardless of their value, whether or not they are offered free of charge, or for a fee (and will interchangeably be used in this document).

3 USERS' OBLIGATIONS

Data Controller

The site is owned and operated by Tooliers Inc and operated by associated companies as mentioned above. Tooliers Ltd (the company operating in the UK) is subject to Data protection regulations and registered with Data Controller at Information Commissioner's Office (UK). Bridge Europe Consulting is registered for operating the confidential information with the Romanian authorities.

Information Gathered About You

We process information in order to be able to handle orders, deliver products / services, process payments, communicate with you about orders, offers, promotions, update our records and maintain your account, display customer's reviews, respond to your requests.

We receive and store any information you enter on our website or provide to us in any other way (account information, search history, orders history).

By using our site, you consent to such processing and you warrant that all data provided by you is accurate, and the information submitted by you does not infringe or breach any confidentiality restrictions you have in place with third parties.

Cookies

Our website uses cookies in order to offer the visitors a better experience when browsing the website, as well as to provide services adapted to the needs and the interests of the visitors.

Cookies offer website owners important feedback on the way visitors browse the websites, so that such websites may be more efficient and more accessible.

Cookies are unique identifiers that we transfer to your device to enable our systems to recognize your device and to provide features relevant to you.

There are two main categories of cookies. **Session cookies** are created temporarily in your browser's subfolder while you are visiting a website. Once you leave the website, the session cookie is deleted. **Persistent cookie** files remain in your browser's subfolder and are activated again once you visit the website that created that particular cookie. A persistent cookie remains in the browser's subfolder for the period set within the cookie's file.
